IAF (INTER-AMERICAN FOUNDATION) FOLLOW UP VISIT

On November 14 and 15 we were pleased to receive a visit from Andrea Tapia, Community Philanthropy consultant for the Inter-American Foundation (IAF), one of our funding partners. A monitoring visit was made to some organizations and collectives (Tierra Roja, Unecodes, Camati, Patrulla Roja and Conider) to take a closer look at the progress of their technical assistance programs and capacity building of their teams.











VISIT TO THE PROYECT OF TLAHTOLLI, A.C.

In its work with young people, Tlahtolli A.C. carried out an awareness-raising activity at the Cobach 11 school.

In the session, the different groups of boys and girls presented interesting proposals in the classroom related to conservation, recycling, endemic species and biodiversity; a way to train as agents of environmental change and to understand the importance of knowing and caring for the environment of San Cristóbal.

The activity culminated in an event held on November 26th at El Encuentro Park, where the young people put together a rally with challenges that they organized themselves.



2024 PROJECT SELECTION COMMITTEE

We are very happy because we are about to know which organizations will collaborate with us in the 2024 cycle. A selection committee, made up of members of the **operational team** and **board of Friends of San Cristobal**, members of the giving circles and project experts, met in evaluation sessions during the months of November and December to review - in light of the existing selection criteria - the **22 proposals** that passed to the second phase of the process.

These projects are mainly in the areas of health, education and the environment and operate in the Chiapas Highlands areas.



The committee is currently in the final stage of the process. The results will be communicated early next year. Best of luck to all the organizations that applied with love to this call for proposals.

FORUM FOR THE EXCHANGE OF EXPERIENCES ON CORE DEVELOPMENT WORK











As part of our year-end activities, on December 13th we held the FORUM "**Recognition and exchange of experiences, achievements and challenges**", which was attended by the organizations and collectives with which we collaborate.

The objective of the meeting was to identify the main components and lessons learned about the projects based on a **better understanding of the grassroots development** approach that the groups have implemented and appropriated from their participation as **collectives and friendly organizations**.

The facilitation was in charge of Adelina Gonzalez; work was done in groups to visualize the progress of the projects and the lessons learned were shared.

The event ended with a beautiful Mayan ceremony of gratitude.

A DAY TO GIVE CAMPAIGN

For this reason, we organized different events and activities for the occasion.

In fact, some of them, since early in the morning, were already waiting for us to finish setting up so they could take the most worthwhile items.

However, it should be noted that this event would not have been possible without the collaboration of all the people who wholeheartedly donated clothes, books, shoes, toys, kitchen utensils, etc. A way, like any other, to contribute to promote solutions to health, education and environmental problems in our region.





TAX DEDUCTIBILITY ON YOUR DONATIONS

Solidarity is not only rewarded on a personal level, but also fiscally. Financial and in-kind donations made to authorized donors can be tax deductible.

Amigos de San Cristobal (ASC) is an authorized donor. We are a SAT-certified organization, so we can issue tax-deductible receipts. This also assures you that your contributions are going to the right place.

Pay less annual taxes with your donations.

Private entities* You may deduct donations that are neither onerous nor remunerative, up to a total amount that does not exceed 7% of the taxable income obtained in the previous fiscal year in which the deduction is made. Private individuals* You can deduct up to 15% of the total annual income or a maximum of 5 times the annual value of the UMA (The Unit of Measurement and Actualization). Within these deductions you can consider donations.

Donations in kind* You can deduct the amount that corresponds according to the tax dispositions: new goods, or goods of your fixed assets. You can give us merchandise that has lost its value to be commercialized. *Subject to changes and current tax regulations. When thinking about the destination of your donation, consider a legally established and authorized organization such as ASC (Amigos de San Cristóbal). Your contributions can have a greater social impact with us because we know the work done in the region. ASC accompanies the work of groups that provide solutions to local problems. We have a solid model of procurement, management and channeling of resources, as well as one of strengthening and evaluation of projects
